**FIRST NCA NOTIFICATION**

Applications are invited only online from qualified candidates belonging to the reservation group of OBC Community of Kerala State for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidate shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission.

- 1. Department** : Kerala Factories and Boilers Service
- 2. Name of Post** : Medical Officer
- 3. Scale of Pay** : Rs. 45800-89000
- 4. Number of vacancies** : NCA - OBC -01 (One)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidate is advised and appointed against the vacancies earmarked for the above mentioned community but remain unfilled and also against vacancies that may arise due to the paucity of candidates during the currency of the Ranked List published on 28/06/17 for the post (Category No.66/2013) .

- 5. Method of appointment** : Direct Recruitment from candidates belonging to the OBC Community only.

Applications submitted by candidates belonging to the communities other than the above will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

- 6. Age limit** : 23-39, Only candidates born between 02/01/1980 and 01/01/1996 (both dates included) are eligible to apply for the post. (Including the age relaxation as per Para 2 (i) of the General Conditions)  
(For other conditions regarding the age relaxation please see part II Para 2 of the General Condition except Para 2(i).
- 7. Qualifications** :
  1. Must possess MBBS Degree from a recognised University with one year House surgency.
  2. Registration under part A of the Kerala Medical Council.

**Preferential:** Post Graduate Diploma in Industrial Health.

Note:- (i) Rule 10 a (ii) of Part II KS & SSR is applicable.

(ii) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

(iii) If there is difference in original caste / community claimed in the application and that entered in the SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate / Community certificate at the time of certificate verification.

- 8 Mode of submitting Application:-**

- (A) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading . There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for. The profile correction made by candidate or in the office of KPSC on request after the last date fixed for the receipt of application will not reflect in the application. Such corrections will be in effect on the date on which correction have made.
- (B) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.
- (C) “Candidates who have AADHAR Card should add AADHAR as ID Proof in their profile.”
