Applications are invited from qualified Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. Candidates who have **AADHAR card should add AADHAR as ID proof in their profile**

- 1 Name of Department** : Kerala Police Service
2 Name of post : Inspector of Police (Telecommunications)
(Special Recruitment for Scheduled Tribes Only)
3 Scale of pay : ₹10,790 – 18,000/- (PR)
4 No. of vacancy : 1 (One)

Note:- The above vacancy is now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribes only during the pendency of the list.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment from among Scheduled Tribes only).

Note:- Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age** : 20 - 36 .
Only Candidates born between 02.01.1986 and 01.01.2002 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

7 Qualifications:

- (1) Diploma in Telecommunication/Radio Engineering or equivalent.
- (2) Experience in the repairs of Electronic Devices or Computers & Accessories for a period not less than 2 years from a Government recognised Institute.

Note: In respect of Defence Service Personnel 3 (Three) years experience in signal Corps (Supervisory) with total service of 5 years will be reckoned as equivalent qualification for Direct Recruitment.

(c) Each eye must have a full field of vision.

(4) Must be certified medically fit for active work.

Note:-

1. Part II Rule 10 a(ii) of KS&SSR regarding qualification is applicable for this selection.
2. Those candidates who have claimed equivalency for qualifications should produce the relevant Government Order to prove the same at the time of verification in order to be considered as equivalent. Candidates claiming higher /equivalent to the qualification for which equivalency is prescribed in the notification should produce equivalency certificate from concerned institution or Government order proving the equivalency.
3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from the revenue authority concerned and the Gazette Notification for the same at the time of certificate verification.

8 Mode of Submitting application:

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission **www.keralapsc.gov.in** before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph uploaded. **Candidates who create their profile from 01/01/2022 should upload photograph taken within the period of six months.** The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.
